QUALIFICATIONS FOR MEMBERSHIP IN HARVEST LAND CO-OP, INC.. "(a) The member of Harvest Land Co-op shall be the holders of its voting common stock who are qualified to hold same in accordance with the provisions of the articles of incorporation and of the bylaws, and who patronize and cooperate with Harvest Land Co-op, Inc.

"(b) Any person, partnership corporation or association who or which is a producer of agricultural products, and any association of such producers may become a member by patronizing Harvest Land Co-op and acquiring at least one share of its voting common stock, and may remain a member of Harvest Land Co-op so long as he or it is a producer, has an interest in the production of agricultural products or is an association of such producers and continues to patronize Harvest Land Co-op. No person, partnership, corporation or association shall be deemed to be a patron of Harvest Land Co-op if he or it has not patronized or done business with Harvest Land Co-op during the immediately preceding three (3) fiscal years."

I hereby certify that I meet the qualifications for membership in Harvest Land Co-op as set forth above; and submit herewith, in payment in full for one share of Harvest Land Co-op's voting common stock to be issued in my name, the sum of \$5.00.
